JOINT PRESS STATEMENT TO MARK NIGERIA'S 59TH ANNIVERSARY

Abuja- The Network of Civil Society Organizations (CSOs) working to promote transparency and accountability in different sectors of the Nigerian polity has come together to commemorate the 59th Independence Anniversary of Nigeria and the 20th Anniversary of Democratic Governance on the 1st of October 2019 in Abuja.

We congratulate all Nigerians on this occasion of our dear nation. The important occasion of Nigeria's 59th anniversary is not just timely but, necessary for reflection on the past 59 years of independence. The independence as well as the democracy of our dear nation is at a crossroads: there are deep seated problems of structure, institutional weakness, performance that are presently jeopardizing the democratic space, basic public good are lacking, the majority of the population is impoverished and there is an epidemic of social violence that has undermined security throughout the Federation. It is important to also note that at 59 and 20 years of democratic governance, Nigeria is still grappling with attaining the 35% affirmative action for the participation of women in governance and security issues.

It is pertinent to note, however, that in spite of the challenges that face us as a nation, there has been remarkable progress in the years since 1960. Successive administrations from Nigeria's independence, have made several efforts to set the country on the right course with each administration establishing some degree of success in various sectors of the polity. The present administration for instance, in 2015, rode into victory on the back of its campaign mantra – **CHANGE**, which Mr. President promised Nigerians will happen by tackling corruption, making the country safe and secure, providing citizens with the basic services through infrastructure that works, healthcare that is affordable, even free; respect for the environment and sustainable development, education that is competitive and outcome-oriented in a knowledge-economy.

Based on this, the Network of CSOs have come together to share with Nigerians, some of the improvement experienced in the past few years:

• The criminal justice system has experienced significant improvement with the Administration of Criminal Justice Act, 2015 which has been adopted and domesticated across 27 states, the Violence Against Persons Prohibition Act (VAPP) which has also been adopted by 10 states, the Proceeds of Crime Laws as well as the Whistle Blower Policy. The judiciary that has been seen to be corrupt is more transparent and has become more accountable.

- There is a level of improvement within the Education sector for example, the provision for free education especially at the primary level, the school feeding programmes, which has contributed to boosting the local economy as well as contribute to the creation of new jobs along the food supply value chain. Notable gains have also been observed in the delivery of quality services on contracts made under the Universal Basic Education Commission (UBEC) intervention funds.
- With the privatization of the power sector, Nigerians are experiencing little improvement with the provision of power supply, although still insufficient.
- The health sector has experienced some improvement, with the maternal mortality rate on the decrease. According to UNICEF, a woman's chance of dying from pregnancy and childbirth in Nigeria is 1 in 13. And in 2015, mortality ratio for Nigeria was 814 deaths per 100,000 live births.

According to a famous Nigerian "A nation is not defined by its borders or the boundaries of its landmark. Rather, the nation is defined by adverse people who have been unified by a cause and a value system and who are committed to a vision for the type of society they wish to live in and give to the future generations to come'.

It is therefore based on this that we call on the government of Nigeria to further strengthen accountability and monitoring mechanisms within the political space, education, health, judiciary and ensure the security of lives and property of citizens. Funding should be allocated for the implementation of progressive laws to achieve their aim and objectives. In addition, as a nation we must hold our leaders accountable and ensure respect for the Rule of Law.

To build a strong independent and democratic Nation, we call on all citizens to put national interest above personal interest.
